COMMENTS

Scope of work is for all visible high-risk trees. Most trees in park will require maintenance pruning as soon as possible. One of the removals recommended is a large Poplar tree trunk. It is popular with bird watchers, and even has a sign saying, "There is life in dead trees". Although I agree, the mitigation of risk and removal of tree will be at the sole discretion of the district. Rigging and pedestrian traffic control will be needed. Loader crew and elevator boom required. Work performed by Local LiUNA 1184 tree workers.
